

LIMITED WARRANTY



Adventure Manufacturing, LLC hereby warrants that any new Voyager golf cart purchased from Adventure Manufacturing, LLC or any Authorized Dealer in the United States, will be free from defects in material and workmanship for two years (or 2,000 miles) from date of purchase, subject to the stated limitations.

During the term of said warranty, any authorized Voyager service technician or Voyager dealer will repair or replace (at Adventure Manufacturing, LLC's option) any part determined to be defective by Adventure Manufacturing, LLC due to faulty workmanship or material from the factory.

Parts used in warranty repairs will be warranted for the balance of the vehicles warranty period.

All parts replaced under warranty become property of Adventure Manufacturing, LLC.

Warranty Exclusions:

1. Routine maintenance items, normal wear and tear, cosmetic deterioration, or electrical components damaged as a result of fluctuations in electrical current.
2. Damage to or deterioration of a vehicle resulting from inadequate maintenance, neglect, abuse, accident, or collision.
3. Installation of parts or accessories that are not original equipment provided by Adventure Manufacturing, LLC or an Authorized Dealer.
4. Fading, rust, or deterioration of any original components of the vehicle or any parts replaced in routine maintenance, due to environmental exposure or ordinary wear and tear.
5. Modifications or alterations that affect the vehicle's condition, operation, performance or durability.
6. Acts of God, ie lightning, hail damage, flooding, fire, etc. or other events over which Adventure Manufacturing, LLC has no control.
7. Noises that develop due to normal wear and tear and proper vehicle operation. (Squeaking or rattling will not fall under warranty coverages).
8. Any and all expenses incurred in transporting the Vehicle to and from Adventure Manufacturing, LLC or an authorized Dealer, technician, or designee for warranty service.
9. Golf carts with more than 2,000 miles on odometer.
10. Golf carts sold to another owner. Warranty on the golf cart, parts or labor coverage are not transferrable.

Customers' Responsibility:

1. Complete and send Warranty Registration Form to Adventure Manufacturing, LLC within thirty (30) days of purchase. Failure to submit Warranty Registration within 30 days of purchase may void warranty coverage. Form may be emailed or submitted online.
2. Operate and maintain the vehicle as specified in the Owner's Manual.
3. Give notice to an Authorized Voyager Dealer of any apparent defects within (10) days of discovery, and make vehicle available at that time for inspection and repairs at the Dealer's place of business or service location.

Liability Limitations:

In no case shall Adventure Manufacturing, LLC be liable for indirect, incidental, special, punitive or consequential damage, including but not limited to death, personal injury or property damage arising from or related to any alleged failure in a cart, battery, or battery charger or any damage or loss to the purchaser or any third-party lost time, property, inconvenience or any economic loss, whether or not Adventure Manufacturing, LLC was apprised of the foreseeability to such damage or losses.

The right of the purchaser to recover damages within the limitations set forth in this section purchaser's exclusive alternative remedy if the limited remedy of repair or replacement of the vehicle fails of its essential purpose.

Any legal claim or action arising that alleges breach of warranty must be brought within three (3) months from the date the warranty claim arises.

Warning:

Any modification or change to the vehicle, battery, and battery charger, which alters the weight distribution or stability of the vehicle, increases or decreases the vehicle's speed, or alters the output of the battery charger beyond factory specifications can result in property damage, personal injury or death. These modifications will void the limited warranty. Adventure Manufacturing, LLC disclaims responsibility for any such modifications, changes, or alterations, that would adversely impact the safe operation of the vehicle or battery charger.
